



SOFTWARE LICENSE AGREEMENT

Intergraph Government Solutions Corporation, hereinafter referred to as "IGS," agrees to a limited, nontransferable, and nonexclusive license under applicable copyrights and/or trade secrets to install and use each Software Product provided by IGS under the following terms and conditions:

1. TERM OF LICENSE

The Software Product(s) shall be licensed under this Agreement effective from the date of delivery. This Agreement shall remain in force until CUSTOMER discontinues the use of such Software Product(s) and returns the Software Product(s) to IGS or this Agreement is otherwise terminated as provided herein.

2. LICENSE COVERAGE

CUSTOMER shall have the right to use each Software Product or any portion thereof, in object code form only, in the specific manner for which it is licensed. Software may be licensed as may be either locked on a single computer node, or concurrently on a number of computer nodes so long as the number of concurrent uses does not exceed the number licensed for the site, or on one or more backup computer nodes. No other use is licensed. CUSTOMER shall permit IGS reasonable access to the site for license audit purposes.

3. SECURITY

Certain Software Products are required to operate in conjunction with a hardware lock device or in conjunction with license administration software and a license authorization key provided by IGS or its representative. CUSTOMER shall take no steps to avoid or defeat the purpose of any required lock device or authorization key. Use of any Software Product without a required lock device or authorization key shall be unlicensed under this Agreement.

CUSTOMER agrees that he and his employees will not make available the software, or portions thereof, or documentation related thereto, to any persons other than CUSTOMER or IGS employees or other persons authorized to use the LAN for which the software is licensed without prior written approval of IGS. CUSTOMER will not copy the software or documentation except as necessary for use under this Agreement. CUSTOMER will not decrypt without authorization, reverse compile or disassemble the software. CUSTOMER will not export or re-export the software or documentation without the appropriate United States and foreign government licenses.



4. TITLE

Title and ownership of the software shall at all times remain with IGS or relevant third parties.

5. DISCLAIMER OF IMPLIED WARRANTIES

IGS HEREBY DISCLAIMS ANY IMPLIED WARRANTIES INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

6. TERMINATION

In the event the CUSTOMER neglects or fails (i) to pay the appropriate license fee(s), or (ii) to adhere to any of its obligations hereunder, this License Agreement shall immediately terminate, and all software licensed hereunder and all encrypted software will be returned to IGS within ten (10) days.

In the event of any proceeding, voluntary or involuntary, in bankruptcy or insolvency by or against CUSTOMER, or in the event of the appointment, with or without the CUSTOMER's consent, of an assignee for the benefit of creditors, or of a receiver, IGS may elect to cancel any unfulfilled part of this Agreement.

7. ASSIGNMENT

This License Agreement, the rights granted hereunder, and the software and any documentation related thereto, shall not be assigned without prior written consent of IGS.

8. AGREEMENT LIMITATION

8.1. It is understood and agreed that this License Agreement and the applicable part of any agreement form that may accompany a Software Product together contain the entire and only understanding between the parties relating to subject matter hereof and that any representation, promise, or condition not contained therein shall not be binding on either party.

8.2. The provisions of this Agreement shall control and have precedence over the terms of any purchase order from CUSTOMER with respect to the licensed programs. Receipt by CUSTOMER of the licensed program, updated program, or optional materials, such as source tapes, decrypting information or listings from IGS, shall be deemed conclusive evidence of CUSTOMER's agreement that the license for such licensed program or optional materials is governed by this Agreement.

8.3. Whenever possible, each provision of the Agreement shall be interpreted in such a manner as to be effective and valid under applicable law. However, if any provision of the Agreement shall be prohibited by or invalid under applicable law, such provision shall be ineffective only to the extent of such prohibition or invalidity without invalidating the remainder of such provision or the remaining provisions of this Agreement.



8.4. This Agreement shall be governed by the laws of the State of Alabama.

9. RESTRICTIONS

9.1 United States Government Restricted Rights. If the SOFTWARE PRODUCT (including any Updates, documentation, or technical data related to such SOFTWARE PRODUCT) is licensed, purchased, subscribed to or obtained, directly or indirectly, by or on behalf of a unit or agency of the United States Government, then this Section 9 also applies.

9.1.1 For civilian agencies: The SOFTWARE PRODUCT was developed at private expense and is “restricted computer software” submitted with restricted rights in accordance with the Federal Acquisition Regulations (“FAR”) 52.227-19 (a) through (d) (Commercial Computer Software – Restricted Rights).

9.1.2 For units of the Department of Defense: The SOFTWARE PRODUCT was developed at private expense and is “commercial computer software” submitted with restricted rights in accordance with the Defense Federal Acquisition Regulations (“DFARS”) DFARS 227.7202-3 (Rights in commercial computer software or commercial computer software documentation).

9.1.3 Notice: This SOFTWARE PRODUCT is “commercial computer software” as defined in DFARS 252.227-7014 (Rights in Noncommercial Computer Software) and FAR 12.212 (Computer Software), which includes “technical data” as defined in DFARS 252.227-7015 (Technical Data) and FAR 12.211 (Technical Data). All use, modification, reproduction, release, performance, display or disclosure of this “commercial computer software” shall be in strict accordance with the manufacturer’s standard commercial license, which is attached to and incorporated into the governing Government contract. IGS and any applicable third party software manufacturer(s) are the manufacturer. This SOFTWARE PRODUCT is unpublished and all rights are reserved under the Copyright Laws of the United States.

9.2 Export Restrictions. This SOFTWARE PRODUCT, including any technical data related to this SOFTWARE PRODUCT, is subject to the export control laws and regulations of the United States. Diversion contrary to United States law is prohibited. This SOFTWARE PRODUCT, including any technical data related to this SOFTWARE PRODUCT and any derivatives of this SOFTWARE PRODUCT, shall not be exported or re-exported, directly or indirectly (including via remote access), under the following circumstances:

9.2.1 To Cuba, Iran, North Korea, Sudan, or Syria, or any national of these countries.

9.2.2 To any person or entity listed on any United States government denial list, including, but not limited to, the United States Department of Commerce Denied Persons, Entities, and Unverified Lists (www.bis.doc.gov/complianceandenforcement/liststocheck.htm), the United States Department of Treasury Specially Designated Nationals List (www.treas.gov/offices/enforcement/ofac/), and the United States Department of State Debarred List (www.pmdtdc.state.gov/compliance/debar.html).



9.2.3 To any entity if you know, or have reason to know, the end use is related to the design, development, production, or use of missiles, chemical, biological, or nuclear weapons, or other unsafeguarded or sensitive nuclear uses.

9.2.4 To any entity if you know, or have reason to know, that an illegal reshipment will take place.

If the SOFTWARE PRODUCT you received is identified on the media as being ITAR-controlled, this SOFTWARE PRODUCT has been determined to be a defense article subject to the U.S. International Traffic in Arms Regulations (ITAR). Export of this SOFTWARE PRODUCT from the United States must be covered by a license issued by the Directorate of Defense Trade Controls (DDTC) of the U.S. Department of State or by an ITAR license exemption. This SOFTWARE PRODUCT may not be resold, diverted, or transferred to any country or any end user, or used in any country or by any end user other than as authorized by the existing license or ITAR exemption. Subject to the terms of this EULA, this SOFTWARE PRODUCT may be used in other countries or by other end users if prior written approval of DDTC is obtained.

You agree to hold harmless and indemnify IGS for any causes of actions, claims, costs, expenses and/or damages resulting to IGS from a breach by you or any User of the export restrictions set forth in this EULA. 9.3 Territorial Use Restriction. Unless otherwise specifically permitted in writing by IGS, use of the SOFTWARE PRODUCT outside the country in which it is licensed is strictly prohibited.

10.0 NON-DISCLOSURE

You understand that IGS possesses information and data, including, without limitation, Intellectual Property, that was developed, created, or discovered by IGS, or which has become known to or has been conveyed to IGS, which has commercial value in IGS's day-to-day business ("Confidential Information"). IGS considers such Confidential Information to be proprietary and confidential. You agree to treat and maintain as proprietary and confidential IGS's Confidential Information and any information or data provided by IGS, in whatever form, as you would treat your own proprietary and confidential information and data, but in any event, no less than with reasonable care, and to comply with all license requirements, copyright, patent, trademark and trade secret laws as they may pertain to any of IGS's Confidential Information or other information or data provided by IGS.
